Devine Limousines

Rules:

1. No alcoholic beverages served to minors.
2. No illegal drugs conducted in limousine
3. Carrier can refuse transportation to anyone under the influence of alcohol or drugs or other substances.
4. Carrier can refuse services to anyone who conducts themselves in an unruly manner.
5. Customers will be charges for any special expenses incurred on their behalf during the time of use e.g., parking fees, items used from vehicle refrigerator, ect
6. Under age children must be chaperoned or have parents written permission to accept responsibility.
7. Customer is liable for damages they or their passengers incur to vehicle.
8. All reservations must be held by advance reservations. Advance reservations deposit not refundable.
9. No smoking inside vehicle.
10. Carrier will not be liable for delays caused by accidents, breakdowns, bad road conditions, snowstorms, and any conditions beyond its control. We will not transport passengers when road or weather conditions make it impractical or dangerous to operate vehicle.
11. No Pets. Exceptions: a blind person with a Seeing Eye dog, provided dog is properly restrained and has current recommend veterinarian shots and does not occupy a seat.
12. Not liable for loss or damage to personal property, unless same has been surrendered to the possession or carrier. Minimum liability shall be limited to \$50.00 per piece of luggage.
13. No Standing up in the sun roof while vehicle is moving.
14. A damage deposit is required when alcohol beverages being served in Limousine.
