AMENDED ORDER SCHEDULING PUBLIC COMMENT HEARINGS

THIS MATTER comes before the New Mexico Public Regulation Commission (the "Commission") upon its own motion. Being duly informed in the premises, the Commission finds and concludes that additional public comment hearings in this case should be held on Monday, July 31, 2017, at two different times at one location, described as follows in this Order.

1. In this case, Public Service Company of New Mexico ("PNM") has requested Commission approval of its proposed rates charged to its New Mexico customers for electric service.

2. Because of the public's strong interest in this case and in order to receive public comment pursuant to 1.2.2.32.A.2 NMAC, the commission has determined that it would be appropriate and in the public interest to hold two public comment hearings on July 31, 2017 in the City of Albuquerque, New Mexico.

3. The first hearing will be held on July 31, 2017 commencing at 2:30 p.m. to 4:00 p.m. at the Cherry Hills Library Auditorium, 6901 Barstow St. NE, Albuquerque, New Mexico 87111. The second hearing will also be held on July 31, 2017, and to accommodate individuals who work during the day the second hearing will commence at 6:00 p.m. to 7:30 p.m and will be

also held at the Cherry Hills Library Auditorium, 6901 Barstow St. NE, Albuquerque, New Mexico 87111.

4. As set forth in 1.2.2.32.A.2 NMAC, any comments received at the public comment hearing shall be for the record but shall not be considered by the Commission as evidence in the case.

A. Two public comment hearings in this case are scheduled for the following dates at the following locations: 1. Monday, June 31, 2017, at the Cherry Hills Library, 6901 Barstow St. NE, Albuquerque, New Mexico 87111, commencing at 2:30 p.m. to 4:00 p.m. 2. Monday, June 31, 2017, at the Cherry Hills Library, 6901 Barstow St. NE, Albuquerque, New Mexico 87111, is commencing at 6:00 p.m. to 7:30 p.m.

B. The Commission may set a time limit on the length of the comments in order to accommodate all persons who seek to provide comment.

C. A copy of this Order shall be served on all parties listed on the attached certificate of service via email, if the email addresses are known, and if not known, by regular mail.

D. This Order is effective immediately.

E. This Order is issued by the Chair of the Commission or by a single Commissioner in accordance with 1.2.230(B)(2) NMAC.


