APPLICATION FORM INSTRUCTIONS

The Application will not be docketed until you have submitted a complete application for a permanent authority to the Transportation Division. For assistance applying for a certificate or permit, see the “Application for a Certificate or Permit.”

Once this Application and the Application for a Certificate or Permit are complete, Transportation Division Staff will docket both applications and, in accordance with 18.3.2.25 E NMAC, the Director will recommend to the PRC that your application for a Temporary Authority be granted or denied.

The following section lists three Exhibits which you must attach to your application. Complete the three exhibits and attach them to the Application form itself, which begins on page 4. If staples, paper clips or bindings of any kind are included, the application will be returned to you. Include a cover page for each exhibit.

EXHIBIT TA-1 Submit sworn affidavits or other verified proof setting forth facts showing that there is an urgent and immediate need for the transportation services applied for. Also, submit information that either no other motor carrier is providing the applied for service in the territory the applicant serves or that another motor carrier is providing the service but the transportation service is inadequate in terms of rates, routes, or service. 18.3.2.25 B NMAC.

EXHIBIT TA-2 Submit sworn affidavits or other verified proof setting forth facts showing that the application is one directly involving public safety, a governmental program, or a specific public event. 18.3.2.25 C NMAC

EXHIBIT TA-3 Transportation Division Staff will assume that all the information submitted with the Application for Certificate and Permit applies to the Application for Temporary Authority. If any information is not the same, provide a detailed explanation and any relevant, new information. (For example, if you will be using a different tariff for your temporary authority or different vehicles, submit an explanation for the change and a tariff or vehicle lists that reflects the temporary service you will provide.)
